- A daily allowance for auditors (380 USD per man-day) is to be charged to clients.
- Audit is to be conducted with 2 or more auditors, depending on the size of fields and factories to be audited.
- Transportation fees and hotel fees (in case of exceeding 8 hours for 1 day including travel time) are to be charged to clients.
- If travel time from Branch to client's audit site takes more than 2 hours for one way, 85 USD per auditor is to be charged to clients.
- Make sure that the payment of certification fees, etc. can be confirmed 2 weeks before the day the site inspection is to be conducted.
- If additional fees were incurred during site inspection, the Client must pay them within 7 days after the site inspection.
