▪ A daily allowance for auditors (400 USD JPY/1man-day) is to be charged to clients.
▪ Audit is to be conducted more than 2 auditors.
▪ Transportation fees, accommodation fees (150USD/1auditor) and nonlife insurance while auditors leave Japan is to be charged to clients.
▪ Since date of departure, 50USD/day per person shall be offered as movement allowance.
▪ If additional fees were incurred during site inspection, the client need to pay within 7 days after site inspection.
▪ A JAS organic training course for clients in English or client's mother tongue, costs each participant 300 USD. (A minimum of about 5 participants)
▪ The place where is specified or will be specified after certification as a dangerous area by Ministry of Foreign Affairs of Japan, is out of the audit.
▪ Bank transfer fee shall be covered by clients .
▪ When clients require irregular audit at the same time as surveillance audit, surveillance audit fee double as irregular audit fee. However, clients require only irregular audit, clients need to pay irregular audit fee.
